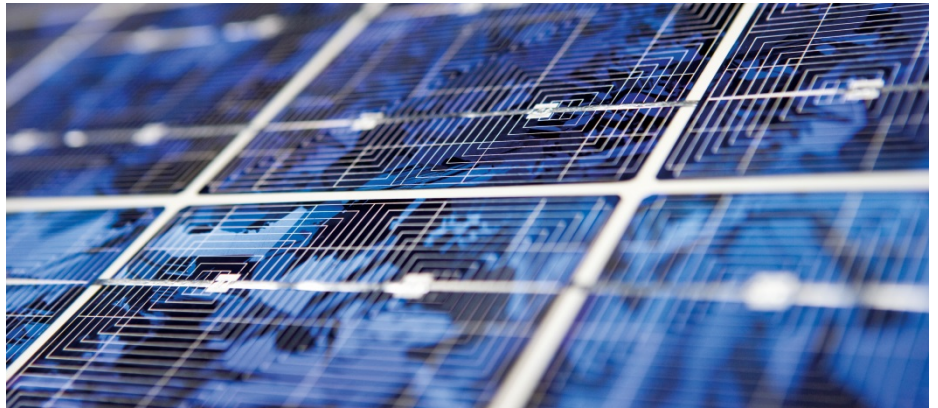


# Personal Data Protection

## Purpose Statement

CHUBB®



1. To process, administer and/or manage your relationship, account and policy with Chubb Asia Pacific Pte Ltd (“Chubb”), Chubb will necessarily need to collect, use, disclose and/or process your personal data or personal information about you.

2. Such personal data will be collected, used, disclosed and/or processed by Chubb for the purpose(s) of :

- (a) carrying out due diligence or other screening activities (including background checks) in accordance with legal or regulatory obligations or risk management procedures that may be required by law or that may have been put in place by Chubb;
- (b) carrying out your instructions or responding to any enquiries by you;
- (c) marketing;
- (d) evaluating your application for employment and for related recruiting, reporting and recordkeeping purposes
- (e) compliance monitoring and audit reviews; and/or
- (f) archiving, backing-up

(collectively the “Purposes”)

3. We may/will also be collecting from sources other than yourself, personal data about you, for one or more of the above Purposes, and thereafter using, disclosing and/or processing

such personal data for one or more of the above Purposes.

4. Your personal data may/will be disclosed by Chubb to its third party service providers or agents including but not limited to:

- (g) Business Partners
- (h) Third Party Vendors engaged by us to store and maintain our records, including storage for business recovery purposes
- (i) Professional Advisors, such as lawyers, legal advisors, doctors and other medical service providers
- (j) Related company or regional office or head office to comply with company policies and procedures or upon their valid request

5. Your personal data may/will disclosed by Chubb to its third party service providers or agents, which may be sited outside of Singapore, for one or more of the above Purposes, as such third party service providers or agents, if engaged by Chubb, would be processing your personal data for Chubb for one or more of the above Purposes.
