Average Clause / Fasal Purata

It is hereby understood and agreed that if the motor vehicle shall at time of any loss or damages (be it partial/total loss) be insured for a sum insured less than its market value then, the Insured shall be considered as being his own Insurer for the difference and shall bear the rateable proportion of the loss accordingly. Provided that this clause shall not apply unless the market value at the time of loss exceeds the insured value by 10%.
