- Sample client correspondence and activity reports

### **STEP 2: Key Dates & Details**

After reviewing your signed addendum, questionnaire, and account listing, we will confirm the following:

- Your enrollment effective date
- Our availability for training webcasts, if desired
- Your CCC specific code(s), which will be used for any business we service

# STEP 3: Client Communication & Interaction

Finally, business is transitioned into the CCC, and we begin working with your staff and clients.

- We seamlessly update the producer code on your CCC accounts.
- Clients receive welcome letters that reference your agency, outline the benefits of working with the CCC, and include our contact information, which will also be included on policy paperwork.
- We handle client calls on your behalf, and your team can contact the CCC directly for new business quoting, endorsements, or policy inquires.
- Additional accounts can be transitioned into the CCC any time at your discretion.
