Type of Claim	Details of Claim
<b>Negligence/ Misrepresentation/ Breach of Fiduciary Duty</b>	A large family-owned organization (the "organization") amended the provisions of an agreement regarding the payoff of loans from the organization to family members. Claimant sued the organization's employed lawyer for negligence, misrepresentation, and breach of fiduciary duty, contending that the employed lawyer failed to disclose the amended payoff provisions and acted in concert with other family members to induce claimant to sign the amended provisions.
<b>Negligence/ Misrepresentation/ Federal RICO</b>	Federal RICO action alleging that defendants, including an employed lawyer, engaged in a scheme to smuggle certain types of goods into a certain state (the "State") to avoid the State's excise taxes and deny the State's wholesalers such as claimant the distribution rights to which they were entitled.

Type of Claim	Details of Claim
<p><b>Negligence/ Breach of Fiduciary Duty</b></p>	<p>Lawsuit filed against an employed lawyer alleging breach of fiduciary duty and negligence, and seeking non-monetary relief in the form of an accounting and removal of a trustee, in connection with the employed lawyer’s drafting of estate documents, preparation of tax returns for a trust, and conduct as trustee for the estate.</p>
<p><b>Malicious Prosecution/ Intentional Infliction of Emotional Distress</b></p>	<p>Lawsuit alleging malicious prosecution and intentional infliction of emotional distress, among other causes of action, in connection with an employed lawyer’s alleged involvement in the termination of claimant’s employment as a manager with the Company and obtaining a Temporary Restraining Order against claimant.</p>
